**HB0011 | OVERDOSE REPORTING AMENDMENTS**

**Sponsor:** Moss, Carol Spackman



**Status:** Governor Signed

**Fiscal Note:** No fiscal impact.

**Description:**

This bill: provides that a person who reports a person's overdose from a controlled substance or other substance may claim an affirmative defense to specified charges of violating the Utah Controlled Substances Act if the person remains with the person who is subject to the overdose and cooperates with responding medical providers and law enforcement officers and . provides that remaining with a person subject to an overdose and cooperating with medical providers and law enforcement is a mitigating factor when determining the penalty for a related violation of the Utah Controlled Substances Act.

**Impact on Children:**

We need to follow this bill because of the potential to save the lives of the K-12 student population who use drugs and then overdose.

**PTA Resolution:** Position Statement taken by the Utah PTA Executive Committee on January 28, 2014 for the 2014 Legislative Session

**Notes:** Utah PTA supports legislation that allows for mitigation of penalty for any person, including those who are minors, when found in violation of the Utah Controlled Substance Act to assist a friend, acquaintance, or other individual who has overdosed on the Controlled Substance and then further assists law enforcement and medical providers to do all that is possible to save a life.

**HB0023 | SUICIDE PREVENTION REVISIONS**

**Sponsor:** Eliason, Steve



**Status:** Enrolled

**Fiscal Note:** No fiscal impact.

**Description:**

This bill amends certain student survey and evaluation provisions related to public school suicide prevention.

**Impact on Children:**

Under certain circumstances, allows a school employee or agent to intervene and ask a student questions regarding the student's suicidal thoughts, self-harming behavior, or thoughts of harming others, for the purposes of referring the student to appropriate prevention services, and informing the student's parent, requires a school district or charter school to develop a policy related to school employee intervention measures on or before September 1, 2014, and allows school personnel to ask a student questions related to youth suicide prevention, intervention, or postvention as part of the school's suicide prevention program.

**PTA Resolution:** [HEA 1998-3 Youth Suicide Prevention](#)

**Notes:** That the Utah Congress of Parents and Teachers support legislation and school district programs which address the development and implementation of a comprehensive (K-12) age appropriate youth suicide prevention program in all school districts in Utah.

### **HB0041 | CLEAN FUEL SCHOOL BUSES AND INFRASTRUCTURE**

**Status:** [Enacting Clause Stricken/Bill Failed](#)

**Fiscal Note:** [Enactment of this bill appropriates one-time Education Fund to the State Board of Education. The \\$20,000,000 can be used for school](#)

buses of certain fuel types and certain infrastructure associated with those fuel types.

**Description:**

This bill provides grants to replace school buses and to create infrastructure for alternative fuel vehicles. Highlighted Provisions: This bill: allows the State Board of Education to award a grant to a school district or charter school to: replace a school bus manufactured before 2002 with a new school bus that uses CNG, propane, or clean diesel fuel, install an alternative fuel fueling station for a school bus that uses alternative fuel and that may be accessed by a governmental entity or the public to fuel an alternative fuel vehicle, or retrofit a bus shop to service and maintain a school bus that uses alternative fuel, requires the State Board of Education to make rules related to the awarding of a grant, including rules that specify criteria for selecting a grant recipient, and require a grant recipient to provide funding matches in an amount that is greater than or equal to the amount of a grant received, and and requires the State Board of Education to:

**Impact on Children:**

Since its founding, National PTA has worked to secure adequate laws for the care and protection of children and youth. ### **HB0071S1 | DISTRIBUTION OF PERSONAL IMAGES**

**Status:** Enrolled

**Fiscal Note:**

**Description:**

his bill provides a definition of "intimate image", provides exceptions for lawful use of images, provides an exception for lawful practices and functions, including law enforcement functions and medical procedures, provides an exemption for defined telecommunication services, and and provides that distribution of an intimate image of an individual, as defined and without that individual's permission, is a third degree felony.

**Impact on Children:**

The penalty for distribution of intimate images, without the individual's permission, will become a Third Degree Felony. Those involved in pornography will continue to distribute photos that have been taken with a child was molested or raped, or made to perform sexual acts. This can follow a child throughout their life and impact them on an on-going basis.

**PTA Resolution:** NPTA Resolution on Sexting: Legal Consequences

**Notes:** Resolved, That Utah PTA urge elected and law enforcement officials at all levels of government and, particularly, the Utah State Attorney General and the United States Attorney General to exercise all of the authority under their jurisdiction to curtail the

production, distribution and exhibition of materials which depict in an explicit manner intimate and sexual conduct and violence of a sexually-oriented nature.

### **HB0077 | TAX CREDIT FOR HOME-SCHOOLING PARENT**

**Sponsor:** Lifferth, David E.



**Status:** Enacting Clause Stricken/Bill Failed

**Fiscal Note:** Enactment of this bill could reduce the Education Fund by \$3,000,000

#### **Description:**

This bill defines terms, provides a nonrefundable tax credit for a home-schooling parent, and provides that the tax credit for a home-schooling parent is subject to apportionment.

#### **Impact on Children:**

The State of Utah has a responsibility to fund public education. Public education is greatly under-funded. This bill makes tax credits available to parents who home school, even if the students are dual enrolled in public school while being home schooled for some part of the day. While parents have the choice to home school, public funds should not be diverted from public schools as a tax credit for home schooling parents.

**PTA Resolution:** EDU 2010-2 Funding for Education

**Notes:** Resolved that Utah PTA oppose vouchers, tax credits and deductions and other similar funding sources for public and private preschool, elementary and secondary school tuition and other education-related expenses for students.

### **HB0081 S1 | PARENTAL REVIEW OF STATEWIDE SUMMATIVE TEST QUESTIONS**

**Sponsor:** Kennedy, M



**Status:** Enacting Clause Stricken/Bill Failed

**Fiscal Note:** No fiscal impact

#### **Description:**

This bill expands a committee of parents or guardians of Utah public education students that reviews computer adaptive test questions and requires the State Board of Education to prepare, and publish on the State Board of Education's website, a report containing information about test questions identified by the committee for certain reasons.

#### **Impact on Children:**

The education experts in the State Office of Education created and continue to create the summative tests. Members of the State Board of Education are elected representatives of the people who review the test questions. It is unnecessary that additional people be brought in to review the work of the State Board.

**PTA Resolution:** EDU 2004-1 State Board of Education

**Notes:** Resolved, That Utah PTA recognizes the State Board of Education as the body elected to establish policy and curriculum for education in the State of Utah.

### **HB0096 | UTAH SCHOOL READINESS INITIATIVE**

**Sponsor:** Hughes, Greg



**Status:** Enrolled

**Fiscal Note:**

**Description:**

This bill creates the School Readiness Board, which provides grants to certain early childhood education programs, and may enter into certain contracts with private entities to provide funding for early childhood education programs for at-risk students. It requires the State Board of Education and the Department of Workforce Services to solicit proposals from qualifying early childhood education providers for quality school readiness grants.

**Impact on Children:**

Studies show that children who receive early interventions through quality preschool programs are less likely to need special education or resource service later. This is very important for at-risk children in a poverty situation.

**PTA Resolution:** FAM 2009-1 Early Childhood

**Notes:** That Utah PTA and its constituent bodies educate parents on the importance of quality early childhood learning experiences, and be it further That Utah PTA and its constituent bodies work collaboratively with existing early childhood programs to better coordinate services, and and be it further That Utah PTA and its constituent bodies advocate for policies and funding to improve early childhood services throughout the state.

### **HB0112S10 | REGULATION OF ELECTRONIC CIGARETTES**

**Sponsor:** Ray, Paul



**Status:** Enacting Clause Stricken/Bill Failed

**Fiscal Note:**

**Description:**

This bill amends the Utah Code to modify and add provisions related to electronic cigarettes

**Impact on Children:**

"This bill is a Utah PTA Priority Bill." This bill prohibits a person from selling or manufacturing electronic cigarettes or electronic cigarette substances without a license from the Department of Health, prohibits a person from selling or manufacturing electronic cigarettes or electronic cigarette substances that contain nicotine that is not pharmaceutical-grade nicotine, prohibits a person from advertising that electronic cigarettes or electronic cigarette substances help an individual stop using tobacco or a product containing tobacco, directs the Department of Health to issue licenses to manufacture or sell electronic cigarettes under certain conditions, provides that the Department of Health can revoke a person's license to sell electronic cigarettes if the person sells an electronic cigarette or an electronic cigarette substance to an individual who is less than 19 years of age, prohibits a business owner from allowing a minor to use an electronic cigarette in the business, prohibits an individual who is less than 19 years of age from buying, attempting to buy, or possessing an electronic cigarette product, and

### **HB0132 | TEMPORARY HOMELESS YOUTH SHELTER AMENDMENTS**

**Sponsor:** Froerer, Gage

**Status:** Enrolled

**Fiscal Note:** No fiscal impact



**Description:**

This bill grants the Office of Licensing rule making authority to make rules establishing age-appropriate and gender-appropriate sleeping quarters in temporary homeless youth shelters, requires a temporary homeless youth shelter to notify the Division of Child and Family Services or a youth services center within 48 hours after the later of: the time that the temporary homeless youth shelter becomes aware that the minor is a runaway, and or the time that the temporary homeless youth shelter begins harboring the minor.

**Impact on Children:**

There needs to be time to evaluate the teens situation and insure we are adequately securing their safety and protection before returning them to their prior situation.

**Notes:** Resolved, Encouraging communities to provide shelter homes, resources and services for the runaway youth

### **HB0168 S1 | SCHOOL AND INSTITUTIONAL TRUST LANDS AND FUNDS MANAGEMENT PROVISIONS**



**Sponsor:** Brown, Melvin R.



**Status:** Enrolled

**Fiscal Note:** Enactment of this bill could cost the School and Institutional Trust Fund Office \$578,000 in FY 2015 and \$865,000 ongoing in FY2016 from the School and Institutional Trust Fund Management Account (which is funded from the Interest and Dividends Account.) The bill may result in higher costs for managing the trust fund assets and could total \$1 million to \$3 million per year. Depending upon returns and management costs, the revenue allocated to school districts from the Interest and Dividends Account may increase or decrease. The bill could cost the School Children Trust Section \$9,000 ongoing from the Interest and Dividends Account and \$2,000 from the Land Grant Management Fund, starting in FY 2015.

**Description:**

This bill comes from the recommendations of the Permanent Fund Task Force commissioned by the State Board of Education. The bill will create a best practices structure for the investment of the Permanent Fund. The State Treasurer will chair an Investment Board, which will hire a Director to work to ensure appropriate long-term investment of the fund.

**Impact on Children:**

The interest and dividends from the Permanent Fund that is distributed to local school community councils. It is essential that the permanent fund is invested well both for the benefit of Utah's current school children and as well as future school children.

**PTA Resolution:** EDU 2004-2 School Trust Lands

**Notes:** Resolved that Utah PTA encourage the Governor, Legislature, State Treasurer, Attorney General, Board of Trustees and Administration of the School and Institutional Trust Lands, other state and local officials to take all necessary steps to assure that management of the School Trust Lands is in accordance with trust duties and principles, including undivided loyalty to the beneficiaries, a duty to make trust property productive, a duty to keep and render accounts, and a duty to exercise prudence and skill in administering the trust, thereby obtaining much-needed revenue for Utah's schools.

**Status:** Enrolled

**Fiscal Note:** No fiscal impact

**Description:**

This bill adds a statement to a statewide or local initiative petition signature sheet stating that a signer has read, understands, and agrees to the law proposed by the petition, adds a statement to a statewide or local referendum petition signature sheet stating that a signer has read and understands the law the petition seeks to overturn, and and makes technical corrections.

**Impact on Children:**

The bill will make it incredibly difficult for the citizens of the state to exercise their constitutional right to petition the government through initiatives and direct referenda, thus hampering PTA's efforts to advocate for the best interests of the children of the

State.

**PTA Resolution:** COM 2008-1 Protecting Utahns Right to Direct Democracy Through Initiatives and Direct Referenda

**Notes:** Resolved #2: That Utah PTA and its constituent bodies support the right of the people to participate in direct democracy through initiatives and referenda and oppose any legislation that weakens their ability to do so

### **HB0213S01 | CRIMINAL PENALTIES FOR SEXUAL CONTACT WITH A STUDENT**

**Sponsor:** Christensen, LaVar



**Status:** Enrolled

**Fiscal Note:**

**Description:**

This bill modifies the offense of aggravated sexual abuse of a child by providing a definition of the term "position of special trust" and clarifying that the definition includes adult employees and volunteers at public and private schools, provides that specified sexual conduct against victims between 14 and 18 years of age are third degree felonies if committed by a school employee or volunteer, and states in the Criminal Code that a sexual offense against a minor is a ground for the revocation of a teacher's license.

**Impact on Children:**

Too many of our students have been molested or in some cases raped while attending schools. Utah PTA as a part of our mission is engaged in the protection of children in the schools. It is important to protect our children in their school environment.

**PTA Resolution:** SAF 1997-1 Safe School-Safe School Policies

**Notes:** "Resolved, That Utah PTA continues to work for enhanced legislation that promotes safe schools."

### **HB0215 S1 | PUBLIC SCHOOL EMPLOYEE BACKGROUND CHECKS**

**Sponsor:** Handy, Stephen G.



**Status:** Enacting Clause Stricken/Bill Failed

**Fiscal Note:** No fiscal impact

**Description:**

Requires the Criminal Investigations and Technical Services Division of the Department of Public Safety to provide notification to certain entities when a new entry is made against



an employee or volunteer whose fingerprints are held on file regarding any matters involving an alleged offense against property and removes the time limit related to criminal offenses of the same type that the State Board of Education may consider when making licensing decision.

**Impact on Children:**

Utah PTA, as a part of our mission is engaged in the protection of children in our schools. It is important to do all that we can to protect children while they are in their school environment. Several of Utah's school children have been molested or raped by school employees. We must do anything that we can to insure that our children are as protected as possible.

**PTA Resolution:** SAF 1997-1 Safe School-Safe School Policies

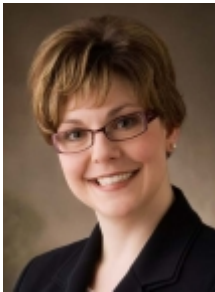
Parent notification files are kept private unless there is a parental release or FERPA-followed court ordered warrant.

### **HB0254S1 | HUMAN TRAFFICKING VICTIM AMENDMENTS**

**Status:** Enrolled

**Fiscal Note:** No fiscal impact

**Description:**

This bill provides that a child is not subject to a delinquency proceeding for prostitution unless the child has been referred to the Division of Child and Family Services on at least one prior occasion for an alleged act of prostitution.

**Impact on Children:**

Children who are lured or forced into prostitution should not be charged for a delinquency proceeding for prostitution. This directly impacts them for life and is often not their fault. These children become victims of those who lure them into this lifestyle by promising them shelter, food, gifts, etc.

**PTA Resolution:** Child Trafficking

**Notes:** Resolved, That National PTA and its constituent organizations advocate for the protection of rights of victims and support efforts to provide measures for the physical, psychological, and social recovery of victims of child trafficking.

Children should be protected and feel safe with the trusted adults in their lives. This bill defines "position of special trust" in regards to adults in a position of authority which enables them to exercise undue influence over a child.

**PTA Resolution:** FAM 2009-2 Child Abuse and Neglect

**Notes:** Resolved, That Utah PTA and its constituent bodies advocate for adequate laws to protect children in all areas of child abuse, neglect, maltreatment, and exploitation.

### **HB0286S2 | CHILD SEXUAL ABUSE PREVENTION**

**Sponsor:** Romero, Angela

**Status:** Enrolled



**Fiscal Note:** No fiscal impact.

**Description:**

The substitution adds that the State Board of Education in partnership with the Department of Health and non-profits organizations that specialize in sexual abuse and prevention will work together to approve instructional materials for the school districts and charter to use.

**Impact on Children:**

This substitute requires schools and charters use materials that have been approved by the State Board of Education. It also allows parents to be notified in advance and allows them to excuse their child from participating or allows them to be in attendance while curriculum is being taught.

**PTA Resolution:** FAM 2009-2 Child Abuse and Neglect

**Notes:** That Utah PTA and its constituent bodies collaborate with schools and community organizations to increase awareness of the problem of child abuse, neglect, maltreatment, and exploitation and to help educate families, children, and educators about the causes of and strategies to prevent abuse, and be it further That Utah PTA and its constituent bodies support prevention and intervention programs that teach positive parenting skills, coping strategies for caretakers, and appropriate response techniques for children, and and be it further That Utah PTA and its constituent bodies advocate for adequate laws to protect children in all areas of child abuse, neglect, maltreatment, and exploitation.

## **HB0305 | SAFETY BELT LAW REVISIONS**

**Sponsor:** Perry, Lee



**Status:** Enacting Clause Stricken/Bill Failed

**Fiscal Note:** No fiscal impact.

### **Description:**

This bill: repeals the provision that provides that the failure to use a child restraint device or to wear a safety belt does not constitute contributory or comparative negligence on the part of a person seeking recovery for injuries and and repeals the prohibition against introducing the failure to use a child restraint device or to wear a safety belt as evidence in any civil litigation on the issue of negligence, injuries, or the mitigation of damages.

### **Impact on Children:**

Since we have started requiring children to wear child restraints we have decreased the loss of children 61%.

**PTA Resolution:** SAF 1998-2 Standard Seat Belt Legislation

**Notes:** Resolved, That Utah PTA and its constituent bodies encourage and support passage of legislation that will endorse standard seat belt law that will increase the effective use of seat belts in the state of Utah.

## **HB0320 S1 | EDUCATORS' PROFESSIONAL LEARNING**

**Sponsor:** Last, B



**Status:** Enrolled

**Fiscal Note:** Enactment of this bill may cost the State Board of Education \$50,000 one-time for an independent consultant to conduct a statewide survey related to educator professional learning.

### **Description:**

This bill: requires a school district or charter school to implement professional learning that meets specified standards, requires the State Board of Education, school districts, and charter schools to: determine resources needed to implement professional learning that meets specified standards, and evaluate the impact of professional learning efforts and resources, and and requires a school district or charter school to use state or federal money designated for professional learning to implement professional learning that meets specified standards.
