## **Rules/Procedure are not the same in every state:**

National PTA releases rules each year. Each state can adjust the rules as desired to be more restrictive than the national rules. We are even allowed to be less restrictive, but this would hurt us in the national competition as our entries could be disqualified, unless we get national permission to have less restrictive rules.



Some states restrict literature entries to 1,000 words. Some don't allow photomontages. Some states allow multiple entries per student in each category. I think Utah is the only state that has 7 categories, separating 2D and 3D artwork. It's very important to read and follow the rules for YOUR state. Hopefully you live in Utah since you are here today. Read and follow the Utah PTA Reflections handbook and rules. Use the Utah PTA Reflections forms and site.



# ONLINE REFLECTIONS

We had 17,855 entries submitted last year through Utah Reflections Online. While there are still some learning opportunities, overall, it is a huge success. Reflections entries will continue to be submitted, managed, and judged 100% online. Reflections first went online for the 2020-2021 year.

# Changes and Enhancements to the Accessible Arts Division

- On the entry form, entrants will select a grade division.

EITHER- their actual grade division, OR the grade division that most closely aligns with their support needs.

- State can advance 2 entries from the AAD per category.



# Changes and Enhancements to the Accessible Arts Division

- **OPTIONAL:** Entrants may utilize Additional Details field to provide information about how their disability and/or support needs impacted their entry.



# Non-Artistic Accommodations


- Students with disabilities may compete in the grade divisions **INSTEAD** of in the Accessible Arts division, and may still utilize non-artistic accommodations.



# NO COMIC BOOKS OR GRAPHIC NOVELS

Illustrated literature entries are still accepted, but the words need to be able to be judged without seeing the pictures, which will not be judged. Illustrations must be drawn by the student. Clip art is not acceptable. Photos are not accepted.



# COMMON ISSUES FOR 3D VISUAL ARTS CATEGORY



- Multiple pieces, loose pieces, not connected
- Art not original - kits, copying internet idea, class project
- Artwork requiring viewer manipulation is not allowed.



# NO COMIC BOOKS OR GRAPHIC NOVELS

Comic books and graphic novels are a hybrid of literature and 2D Art. There is not a category in Reflections where comic books can shine, so they are not allowed. This change was implemented three years ago, but still needs to be strongly emphasized at the schools.



# NO FRAMES/NO SHADOW BOXES

Frames and shadow boxes are not allowed. A shadow box has glass in it. Frames have glass too. If a student wishes to use a frame or anything like a frame as a piece of the artwork, rather than using it in the traditional way to frame the artwork, they will need to get permission from the **state** to include a frame. Exceptions will not be given to entries with glass still in a frame or shadow box. Three examples that were given an exception:





While this entry uses some sort of premade box, it's not used as a shadow box, there is no glass, and it is part of the art.

This entry originally was created in a shadow box with glass. The student was given a chance to remove the glass and pour resin over the entire entry so that it would comply with the rules.





This entry used the wooden part of a frame in a nontraditional way for 3D art. This type of use is borderline and decisions are made case by case by the State Reflections Committee.



Even if the student decorates the frame, it is not allowed. There will be no exceptions for framed art in the 2D category. However, mats are allowed.

# COMMON ISSUES FOR PHOTOGRAPHY CATEGORY



- Confusion about mats vs. mounting
- Added graphics or words
- Student not cameraperson
- Borders/neutral space



# BIGGEST PHOTOGRAPHY ISSUE

## Borders

- Borders may not be digitally added to a photography entry, including simple ones such as black and white.
- No borders
- Don't use borders
- Borders are not allowed



Why do we have dimensions for photography if it is all judged online nationally?

I don't know why national PTA still has a size limit for their photos, because they are advanced digitally. But, Utah PTA chose to set the limit at 11X14 because that size should be adequate for any photography entry to be seen well without being so large that it becomes difficult to transport/store.

We have received permission from the national level to have a larger size limit than the national standards.



# COMMON ISSUES FOR FILM PRODUCTION CATEGORY



FILM PRODUCTION is the process of making a film. All filming, screenwriting, directing, and editing must be done by the student producer. All entries must contain only original student footage. The student must be in control of the camera at all times, including when using a tripod, selfie stick, drone, or other film capturing devices. Entries created using presentation software such as PowerPoint and Google Slides are prohibited.

- Student submitting the entry **MUST** be the cameraman.



# COMMON ISSUES FOR DANCE CHOREOGRAPHY CATEGORY



The choreographer (student submitting entry) may be the performer or one of the people performing, but the choreographer does not have to perform in the entry. All choreography must be done solely by the student entrant.

### Common Issues:

- Entry is not dance choreography.
- Multiple students choreographed entry.
- Routine not original.
- Character copyright violation - costumes, artist statements



# CHANGES/COMMON ISSUES FOR MUSIC COMPOSITION CATEGORY



Notation is optional for Primary, Intermediate, and Accessible Arts Divisions. Last year, National did not allow us to upload it for those divisions, so we took the option away, but it was allowed this year, so we are bringing it back.



This change happened 3 years ago, but many specialists did not read the rules and disqualified entries for submitting a technical reflective statement.

Middle and high school grade divisions require either a music score/notation (traditional or tablature) or a written reflective statement that provides a musically technical explanation of how the music was created (100 words or less).



# WHAT TYPES OF THINGS SHOULD BE INCLUDED IN A REFLECTIVE STATEMENT?

- What creative and musical decisions did you make to achieve the final version of the piece?
- How were the musical elements developed?
- What equipment was used (if any)?
- What sounds and/or musical ideas were used to represent certain ideas or emotions?
- How were your creative and musical decisions influenced by your expertise, context, and expressive intent?

(Found on the Music FAQs)



## Common Issues:

- parent wrote accompaniment
- notation/reflective statement not included for Mid/HS divisions
- incomplete notation - all parts included in recording must be notated
- song is not original composition



# QUALIFYING ENTRIES



# WHAT DOES IT MEAN TO QUALIFY ENTRIES?

1. Qualifying entries means checking them to ensure they followed all of the rules for Reflections - category and general.
2. It's best to qualify entries BEFORE judging. If you can't, do it before assigning awards.
3. Entries that “automatically” win must still be qualified.
4. Once an entry is qualified, it can earn an award. Awards are given based on highest scores, however low those might be.



Utah Reflections Online makes qualifying so easy. The online entry form weeds out a lot of previous issues. We still had to disqualify a few entries at state.



In 2019-2020 the state committee disqualified 14 of 83 film entries submitted to state. They were from 11 of the 18 participating regions. This statistic made us realize that **QUALIFYING** entries needs to happen on **EVERY** level and that training on qualifying is needed.

In 2020-2021, we only disqualified 2 film entries at the state level - for the parent filming, and for a lack of a consent form. However, many entries were disqualified for these reasons at lower levels.



We've made AMAZING progress! In 2021-2022, only 6 entries total were disqualified at state. But, 448 entries were disqualified overall.

Dear Ms. Schafer,

Hi. I am the Utah PTA Reflections Specialist. Reflections entries are currently in the judging process at the state level. One of the judges who judged Sophia's piece was also a judge for art at the Springville art museum and saw a piece of art that was very similar to Sophia's. She notified me and sent me pictures. This prompted me to do a reverse image search, which brought up many images of artwork that looked very similar, including one piece that looked nearly identical.

Copying existing artwork is against the rules for Reflections. I know that this is a common practice in the art world for learning and for fun, but it is not allowed in Reflections. Artwork must be the original creation of the entrant and cannot be copied from another person's idea or work. I will post links to the official rules and category specific rules so that you can read them. Sophia is clearly extremely talented, and I'm sure that this was an unintentional rule violation. Unfortunately, at this point, I have to disqualify her entry from competition. I know this must be very disappointing to her. This part of my job is very hard to do, but I feel it is very important to let students know when their pieces are disqualified, and tell them why, so that they can learn from it and not face the same issue in the future. I hope that she will choose to compete next year. The theme will be "I Belong".



Every year the state has to disqualify entries from schools not in good standing - for failure to pay membership or expired bylaws. Regions may not give Awards of Excellence to entries from schools not in good standing, meaning those entries cannot advance to state.



Councils: If you have an entry with unpaid membership or expired bylaws, please inform the PTA president at that school and let your region know. By the time the entry gets to region, it's too late to get bylaws re-done in time.

Locals: Get your membership paid and your bylaws updated. December 1st is a HARD deadline for these issues to be resolved. I am not authorized to offer any leniency on that deadline.

# QUALIFYING ENTRIES BEFORE ASSIGNING AWARDS

It's not always reasonable to expect that you will have time to qualify each entry according to the rules before sending them for judging. But, entries are **NEVER** to be judged without a title and artist statement, except for Accessible Arts division entries.



# QUALIFYING ENTRIES BEFORE ASSIGNING AWARDS

After judging, review your entries that earned the highest scores.

Review one category at a time. Read the rules for that category carefully before beginning.



# QUESTIONS TO ASK WHEN QUALIFYING ENTRIES

Have I reviewed the artist statement and title? This can help catch issues such as a student playing a piece he/she didn't compose, dancing to a song with choreography that wasn't created by the entrant, and copyright violations.

Have I watched the film, dance, or listened to the music? Is the student the cameraman? for the entire film? Is notation/reflective statement included in Middle and HS music? If there are vocals, is vocal notation included?



# QUESTIONS TO ASK WHEN QUALIFYING ENTRIES

Do any 3D Visual Arts entry pieces contain loose or multiple pieces or require assembly?

Are Photography entries free of added graphics or words? Added graphics means images that were not photographed by the entrant (including borders around pictures).



# QUESTIONS TO ASK WHEN QUALIFYING ENTRIES

Do any entries focus on a copyrighted character or item? Ask “If this copyrighted portion were removed, would it significantly alter the work?” If so, there is a copyright problem. Is it incidental? Something incidental could be removed and the essence of the piece would remain the same. Then it can stay.



# QUESTIONS TO ASK WHEN QUALIFYING ENTRIES

Sometimes it is clear when a piece has a violation. Other times, it is not clear. In those instances, it is best to ask the student or parent for clarification. If the piece does need to be disqualified, this is an opportunity to educate both the student and the parent and gives the student a better chance of having a winning entry the following year. At times, the violation is something that can be fixed if time allows. Often, it is not possible to fix it without the student starting over or significantly altering the piece. In those instances, explain the issue, but still disqualify the piece.

**DO NOT GIVE AWARDS TO DISQUALIFIED ENTRIES.**



# SAMPLE ARTIST STATEMENTS THAT INDICATE A POSSIBLE VIOLATION

“Our dance relates to the theme because in the dance we are stuck doing the same thing and then we find ourselves and we don't need to copy each other any more.”

Don't assume. Ask the student/parent if the piece is the work of the student or if the students collaborated. In almost every situation where rules were violated, the student/parent didn't understand the rules and the violation was not intentional. The piece must still be disqualified, but use this opportunity to teach the rules and show compassion.



# SAMPLE ARTIST STATEMENTS THAT INDICATE A POSSIBLE VIOLATION

“My mom helped me build this robot. It fits the theme because if you look inside you will see what makes it work.”

Don't assume. Ask the student/parent what type of help was involved. Maybe the mother only helped by purchasing supplies. If that is the case, invite the student to change the artist statement.


