HB0013 | PROTECTION OF CHILDREN RIDING IN MOTOR VEHICLES

Sponsor: Arent, Patrice

<u>M.</u>



Status: Signed by Governor

Fiscal Note: Beginning in FY 2015, enforcement through the courts will cost about \$6,600 in ongoing General Fund that will be off-set by annual General Fund revenue of \$5,000 from fines for a net annual impact of \$1,600.

Description:

This bill defines smoking, prohibits a person from smoking in a motor vehicle if a child who is 15 years of age or younger is a passenger in the vehicle, provides that violating the smoking prohibition is an infraction and has a maximum fine of \$45, provides that until July 1, 2014, a peace officer may not issue a citation to an individual for a violation of this section but shall issue the individual a warning informing the individual that smoking is prohibited in a motor vehicle if a child who is 15 years of age or younger is a passenger in the vehicle, provides that a court may suspend the fine for a violation if the person has not previously been convicted of smoking in a vehicle when a child is present and proves that the person has enrolled in a smoking cessation program, provides that enforcement of the smoking prohibition shall be only as a secondary action, and and provides that a violation of the smoking prohibition may not be used as a basis for or evidence of child abuse or neglect.

Impact on Children:

This bill provides that enforcement of the smoking prohibition shall be only as a secondary action. Important to the health of children this bill prohibits a person from smoking in a motor vehicle if a child who is 15 years of age or younger is a passenger in the vehicle and provides that a court may suspend the fine for a violation if the person has not previously been convicted of smoking in a vehicle when a child is present and proves that the person has enrolled in a smoking cessation program.

Notes: Resolved, That Utah PTA continue to educate parents and youth concerning the hazards of secondand third-hand smoke and the damage it can do to the lungs of children, and be it further Resolved, That Utah PTA and its constituent bodies encourage parents to ban smoking inside their homes and cars for the health of their children, and and be it further Resolved, That Utah PTA and its constituent bodies support legislative efforts to protect children and youth from second- and third-hand smoke.

HB0022 | UTAH COMMISSION ON SERVICE AND VOLUNTEERISM

Sponsor: Bird, Jim

Fiscal Note: No fiscal impact

Description:

This bill changes the name of the Utah Commission on Volunteers to the Utah Commission on Service and Volunteerism and modifies the membership and size of the commission.

Impact on Children:

This bill would expand the Commission on Volunteerism and Service which ultimately benefits Children in many areas as they are impacted by the focus of the service to the community. There are also High School youth Groups who participate as Volunteers and learn service to benefit their own communities and the state at large.

HB0031 | ENTICING A MINOR AMENDMENTS

Fiscal Note: No statewide fiscal impact.

Description:

This bill clarifies that the elements of the offense of enticing a minor do not include intent to complete a sexual offense with a minor, modifies the definition of "text messaging", and and provides that the penalties for enticing a minor are based on the level of sexual conduct the actor solicits, seduces, lures, or entices, or attempts to solicit, seduce, lure, or entice a minor to engage in.

Impact on Children:

As laws are and penalties are changed Utah PTA looks only at the best interest of the child and works to ensure children are not exploited.

PTA Resolution: National PTA Resolution On Child Trafficking

Notes: Resolved #1: That National PTA and its constituent organizations support the adoption and enforcement of laws that will deter the recruitment, transportation, transfer, harboring, or receipt of children for the purpose of exploitation.

HB0040 | SCHEDULING OF SPECIAL ELECTIONS

Fiscal Note: No fiscal impact

Description:

This bill amends the dates on which the governor, Legislature, or the legislative body of a local political subdivision may schedule, respectively, a statewide or local special election and and makes technical changes.

Impact on Children:

Special Elections for Bonding and Tax purposes affect the overall funding for Educational purposes.

HB0050 | DATING VIOLENCE PROTECTION ACT

Fiscal Note: Enactment of this bill will cost the Courts \$124,200 ongoing from the General Fund beginning in FY 2014 for judge and court clerk time. Provisions of the bill will also cost the

Department of Corrections an estimated \$27,400 in FY 2014 ongoing from the General Fund for incarceration costs.

Description:

This bill provides for the issuance, modification, and enforcement of protective orders between parties who are, or who have been, in a dating relationship when the parties are emancipated or 18 years of age or older. The parties must have been in a dating relationship with each other and one of the a parties commits abuse or dating violence against the other party. This bill further describes the conditions that may be placed on an alleged perpetrator of dating violence in a protective order.

Impact on Children:

Those student who are 18 years old, including those still possibly in high school, when involved in a violent relationship will have a legal recourse to get a protective order. Currently this option is not available because the current law only allows for protective orders if there is a child between the parties or in the case of cohabitation.

PTA Resolution: STU 2009-1 Teen Dating Violence

HB0052 | CONTROLLED SUBSTANCES REVISIONS

Sponsor: Ray, Paul

Fiscal Note: No fiscal impact.

Description:

This bill adds new "spice" and "bath salts" analogs to the list of unscheduled controlled substances and and makes a technical spelling correction of a substance listed in the scheduled controlled substances.

Impact on Children:

This bill adds additional chemicals that are currently used in designer drugs that are harmful to kids. These drugs are addictive, affect their brain development, and create reactions from kids that are very similar to LSD, Marijuana, etc.

PTA Resolution: HEA 2007-1 Substance Abuse

Notes: Resolved 2 - The Utah PTA supports legislative action that institutes or appropriately increases criminal penalties for individuals or organizations promoting substance abuse of any kind (including the sale or distribution of alcohol and/or tobacco to underage persons) and and be it further.

HB0055 | AMENDMENTS RELATED TO EDUCATION FUNDING

Sponsor: Briscoe, Joel K.

Fiscal Note: By fixing the personal exemption at \$2,850, enactment of this bill increase income tax revenue \$9,155,000 in FY 2014 and \$9,796,000 in FY 2015

Description:

This bill establishes a set tax rate for the minimum basic tax rate, subject to the rate generating a specified revenue amount, eliminates an advertising requirement related to the minimum basic tax rate, and changes the personal exemption component of the individual income tax credit calculation from a percentage of the federal personal exemption to a fixed dollar amount per exemption.

Impact on Children:

Most of the funds for public education come from state income tax and local property tax. As we have seen in the past ten years, the ups and downs of the economy affect revenue for education. When times are good, programs that are very helpful to education get started and when times get bad, these programs are likely to be cut, creating a herky-jerky system and the students suffer for it. This bill helps smooth the bumps caused by economic conditions. It creates a "floor" for education funding and allows funding to increase as conditions improve. This will provide more stable education funding and more reliable education for all students.

HB0059 | SCHOOL BOARD ELECTIONS PROVISIONS

Sponsor: Nielson, Jim

Status: Enacting Clause

Fiscal Note: Enactment of this bill may increase statewide election costs by up to \$550,000 every four years, beginning FY 2015. It may increase local governments' costs by up to \$2.3

million every four years.

Description:

This bill defines terms, requires the direct, nonpartisan election of members of the State Board of Education, repeals the involvement of the governor and the nominating and recruiting committee in the nomination of candidates for the State Board of Education, establishes the primary election for the State Board of Education and local school boards on the second Tuesday following the first Monday in August of an odd-numbered year, establishes the general election for the State Board of Education and local school boards on the first Tuesday after the first Monday in November of each odd-numbered year, designates a county clerk as the election officer for the election of the State Board of Education and local school boards, requires a notice for a school board election, establishes a ballot form for school board elections, establishes declaration of candidacy requirements for school board elections, establishes requirements for a school board primary election, changes the dates of an interim report of campaign finances, adjusts terms of current and future board members, and and makes conforming and technical amendments.

Impact on Children:

This bill is a Utah PTA Priority Bill. It repeals the current statewide, central nominating and recruiting committee and restores direct, nonpartisan election of the State School Board. It moves the election of state and local school board members to odd numbered years along with other nonpartisan elections.

PTA Resolution: EDU 2004-1 State Board of Education

Notes: Resolved #2: That Utah PTA support legislation to restore nomination to, and election of, members of the State Board of Education in a way that is more responsive to the constituency of each State School Board district.

HB0103 | WIRELESS TELEPHONE USE RESTRICTIONS

Sponsor: Perry, Lee B.

Status: Signed by Governor



Fiscal Note: Enactment of this bill will result in a \$1,200 per year net increase in Ongoing General Fund revenue beginning in

FY 2014. Enactment of this bill will cost the courts \$4,000 per year from the General Fund. The bill will also generate about \$5,200 per year in new General Fund revenue.

Description:

This bill prohibits a person younger than 18 years of age from using a wireless telephone to communicate with another person while operating a motor vehicle, provides affirmative defenses to the wireless telephone prohibition, specifies a penalty for violating the wireless telephone prohibition, provides that a violation of the wireless telephone prohibition is not a reportable violation, and prohibits the Driver License Division from assessing points against a person's driving record for being convicted of violating the wireless telephone prohibition.

Impact on Children:

It would make them safer drivers

HB0105 | SERIOUS YOUTH OFFENDER AMENDMENTS

Fiscal Note: No fiscal impact

Description:

This bill requires a youth court that accepts referrals to be certified, allows the proceedings of youth courts to be shared with the referring agency, victim, and juvenile court under certain circumstances, expands the membership of the Youth Court Board to include the president of the Criminal and Juvenile Justice, extends terms of office of board members to four-year, rather than two-year terms, and and makes technical corrections.

Impact on Children:

PTA Resolution: NPTA Position Statement on Child Safety and Protection

Notes: Promote alternative dispute resolution techniques that provide a range of possible sanctions.

HB0118 S02 | AUTOMATIC EXTERNAL DEFIBRILLATOR ACCOUNT

Fiscal Note: This bill appropriates \$300,000 General Fund annually from FY 2014 through FY 2016 into the newly created

<u>General Fund Restricted--Automatic External Defibrilator Account and then from that account to the Department of Health.</u>

Description:

This bill creates the Automatic External Defibrillator Account, provides for the use of account funds, grants rulemaking authority to the Bureau of Emergency Medical Services for the use of account funds, and and establishes restrictions on how account funds may be used.

Impact on Children:

By having an AED in the schools, it could save the life of a child that is going into cardiac arrest.

PTA Resolution: National PTA Position Statement: Child Safety and Protection

Notes: Raise awareness of the need for safe recreational equipment and facilities, playground safety, protective sports gear, and school bus safety.

HB0139 S5 | SCIENCE, TECHNOLOGY, ENGINEERING, AND MATHEMATICS ACTION CENTER

Fiscal Note: Enactment of this bill appropriates \$15,000,000 ongoing General Fund to the Governor's Office of Economic Development for establishment of the STEM Action Center. The \$15,000,000 ongoing appropriation is partially offset in FY 2014 by a \$5,000,000 one-time General Fund reduction to the Governor's Office of Economic Development. The bill also appropriates \$5,000,000 one-time General Fund in FY 2014 to the State Board of Education for grants to school districts and charter schools for STEM

Description:

This bill: creates a Science, Technology, Engineering, and Mathematics (STEM) Action Center Board, requires the STEM Action Center Board to: establish a STEM Action Center, and appoint an executive director to oversee administration of the STEM Action Center, requires the Governor's Office of Economic Development to staff the STEM Action Center Board and the STEM Action Center, requires the STEM Action Center Board to select providers, through a request for proposals process, to provide education related instructional technology, requires the STEM Action Center Board to work with private industry to obtain private funding and support for the STEM Action Center, requires the STEM Action Center Board to perform certain duties related to the STEM Action Center, requires the executive director to track student achievement and progress in STEM areas, requires the STEM Action Center Board, and all providers selected through a request for proposals process, to report to the Education Interim Committee, the Public Education Appropriations Subcommittee, and the State Board of Education once each year, and and requires the State Board of Education to award grants to school districts and charter schools for STEM related education courses if certain conditions are met.

Impact on Children:

The focus of the STEM Action Center is to collaborate with the State Board of Education, to generate best practices for encouraging greater achievement among students in STEM fields, to support and facilitate professional development. By having the Action Center under the direction of the Governor's Office of Economic Development is bringing more advocates to the cause of public education.

PTA Resolution: EDU 2011-1 Excellence in Teaching

Notes: Standard 6: Collaborating with Community Families and school staff collaborate with community members to connect students, families, and staff to expanded learning opportunities, community services, and civic participation. Resolved #2: That Utah PTA support high standards for teacher preparation, licensing, hiring, recertification, professional development, particularly for beginning teachers, and ongoing training as curriculum changes, in order to promote the academic achievement of all students

HB0269 | TRAINING OF **SCHOOL NURSES**

Fiscal Note: Enactment of this bill will not materially impact the state budget.

Description:

This bill permits a school nurse to treat a child who sustains a concussion or traumatic head injury during school hours on school property, prohibits a school nurse from providing a written statement permitting the child to return to physical education class after sustaining a concussion or traumatic head injury unless the nurse has been trained in the evaluation and management of a head injury, and and requires a school nurse to, as funding allows, undergo training in the evaluation and management of a concussion, unless the school where the nurse is employed has an athletic trainer or other qualified health care provider who is trained in the evaluation and management of a concussion.

Impact on Children:

The safety of children is important to parents and school personnel. More today than ever information is coming forth about the serious nature of head injuries. Utah PTA knows our children will be best served if school nurses are prepared and able to assist immediately after a head injury occurs.

PTA Resolution: National PTA Resolution on School Health Councils

Notes: Resolved, That National PTA and its constituent organizations (Utah PTA) support health education efforts throughout the entire school, including in cafeteria offerings and physical education programs.

revenues and expenditures of the same amounts. In subsequent years the Education Fund base will be increased by 25% of the new liquor revenue growth.

Description:

This bill defines terms, directs the deposit of 25% of the growth in the amount of liquor revenues to the Education Fund, provides for the distribution of the liquor revenues to local educational agencies, and and addresses money deposited into the Education Fund.

Impact on Children:

Passage of this bill offers increased sources of funding for public education.

to \$4,000 per school.

Description:

This bill requires a school district to conduct or update a seismic safety evaluation of a school district building constructed before 1975 if the school district issues certain general obligation bonds on or after July 1, 2013 and and provides that a school district is not required to conduct or update a seismic safety evaluation of a building constructed before 1975 if a seismic safety evaluation was performed on the building within the 25-year period before the school district issues certain general obligation bonds.

Impact on Children:

PTA Resolution: SAF 2012-1 Utah Students at Risk, Need for Rapid Visual Screening Seismic Study

Notes: That the Utah PTA urge the Legislature to adequately fund, from other than the General Education Fund, to complete a "rapid visual screening of all school buildings built before 1974

This bill provides that a state or local law enforcement officer may only enforce the safety belt restraint requirement as a secondary action on a highway with a posted speed limit of 45 miles per hour or less.

Having seat belt required as a primary offense increases awareness of the importance of using seat belts thereby saving the live of children especially at freeway speeds.

HB0298 | PARENT SEMINAR ON YOUTH PROTECTION

Fiscal Note: No fiscal impact

Description:

This bill modifies Title 53A, Chapter 15, Standards and Programs, by requiring the State Board of Education and school districts to implement a parent seminar on various issues. This bill requires school districts to offer an annual seminar to parents with information on substance abuse, bullying, mental health, and Internet safety, requires the State Board of Education to develop a curriculum and provide it to requesting school districts, and report on the program to the Education Interim Committee, and and requires a school district to notify charter schools located within the school district's boundaries of the parent seminar.

Impact on Children:



Revenue loss to the Education Fund cannot be determined at this time as the future size of any individual exchange is unknown.

\$10,000,000 of outstanding obligations at any one time, details components of a high quality preschool program that may be funded through a results-based contract between the board and private investors, describes a home-based technology program that may be funded through a results-based contract between the board and private investors, and and establishes reporting requirements.

Impact on Children:

This bill addresses the needs of children who are in need of special help and may be economically disadvantaged. This bill provides an individual income tax contribution for the Invest More for Education Account, creates a restricted account known as the Invest More for Education Account, including: providing funding for the account, and providing that the Legislature may appropriate money from the account for the support of the public education system, and provides that if the collections from the contribution do not meet a certain threshold amount, the State Tax Commission shall remove the designation for the contribution from the individual income tax return and may not collect the contribution.

Impact on Children:

Polls have indicated that the public wants to see greater funding for education and are willing to be taxed for it. This bill would allow tax payers to contribute voluntarily to education. Budget cuts leave schools to struggle meeting needs. If this will give schools more revenue, children's education will benefit.

SB0169 | EDUCATION TASK FORCE

Fiscal Note: This bill appropriates \$64,000 one time to pay the costs of the task force

Description:

This bill creates the Education Task Force, provides for membership of the task force and compensation for members, and and specifies duties and responsibilities of the task force.

Impact on Children:

The legislature has responsibility for funding of public education. Meetings of the Education Task Force give legislative leaders the opportunity to learn about the vision, goals, budget priorities, and education standards from the State Board of Education. Currently, there is little opportunity for this sort of exchange outside the context of supporting or opposing one or another piece of proposed legislation. Communication is a necessary first step in uniting efforts to strengthen public education and coordinate efforts for college and career readiness.

SB0243 | BULLYING AND HAZING AMENDMENTS

This bill modifies provisions regarding bullying and hazing of school employees and students. This bill: amends the definitions of bullying and hazing, requires a local school board or charter school governing board to update the school board's policies regarding bullying, cyber-bullying, hazing, and retaliation by September 1, 2013, and and makes technical and conforming amendments.

Impact on Children:

Bullying is a worldwide problem that can have negative consequences for the general school climate and for the rights of students to learn in a safe environment without fear.

PTA Resolution: SAF 2001-1 Bullying

Notes: That each local unit work with the school administration to develop a school program in compliance with district policies, designed by the entire school community, including parents, teachers, students, professional staff, custodial staff and others, that includes a list of rules, posted in each classroom, against bullying to create a school climate where bullying is not tolerated.

SB0271 S03 | SCHOOL GRADING AMENDMENTS

Sponsor: Adams, J. Stuart



Status: Signed by Governor

Fiscal Note: Enactment of this bill may cost the State Board of Education \$20,000 one-time from the Education Fund to conduct database programming and reporting changes to implement the personal student achievement reports outlined in the bill.

Description:

This bill: specifies that the school grading system shall be known and referred to as "school grading", modifies the criteria and procedures for determining school grades, including: the calculation of learning growth, the calculation of a high school's graduation rate, and the measurement of high school students' college and career readiness, and and requires the State Board of Education to annually develop a personal student achievement report for each public school student to be delivered to the student's parent or guardian.

Impact on Children:

Utah PTA is committed to improving accountability and communication to parents and to the public about school performance. Evaluation of a school's performance must include more than just student achievement. This would include such factors as teacher qualifications and use of professional development, class size, school safety, and drop out rates. Data relating to school performance must be put in context with other factors that can affect student performance such as the level of parent involvement, socio-economic status of families, level of student mobility, and the availability of other student support services.

PTA Resolution: EDU 2000 Public Grading of Public Schools -- Position Statement reaffirmed 2008

Notes: Based on the above concerns, (see Impact for Children) the Board of Directors of Utah PTA opposes public grading of public schools. Publishing grades for or ranking of schools will not reflect the overall achievement and level of performance for that school.
