Sponsor: Noel, Michael E.

Status: Governor Signed



Fiscal Note: Enactment of this bill appropriates \$500,000 ongoing from the Education Fund to the State Board of Education to fund the four-year Pilot

Teacher Retention Grant Program as outlined in the bill.

#### **Description:**

This bill creates a pilot program related to teachers at American Indian and Alaskan Native concentrated schools located in certain areas.

### Impact on Children:

This bill is an effort to strengthen education for American Indian and Native Alaskan children in the state of Utah.



### **Impact on Children:**

According to the National Center for Missing and Exploited Children, roughly 800,000 children are reported missing each year in the United States -- that's roughly 2,000 per day. Of those, there are 115 child "stranger abduction" cases each year, which means the child was taken by an unknown person. And in Utah alone the Utah ICAC Task Force from January 2015 to December 2015 received 2,867 documented complaints and 733 cyber tips associated with sexual exploitation of a minor. By having a day devoted to raising awareness of missing and exploited children we can hopefully increase prevention and lower the statistics to zero someday.

### **HB0057** | **REPRODUCTIVE HEALTH** AND MEDICAID AMENDMENTS

Sponsor: King, Brian

Status: Held in House Business and Labor Standing Committee

Fiscal Note: Enactment of this bill may cost the Department of Health onetime computer programming costs of \$92,500 General Fund and \$267,500 federal funds in FY 2017 and \$10,000 General Fund and \$90,000 federal funds



Utah PTA Support in FY 2018 as well as ongoing costs beginning in FY 2018 of \$1,000,000 General Fund and \$9,000,000 federal funds to provide family planning services to 35,800 low income individuals who do not qualify for Medicaid. Additionally, this bill may cost the Department of Workforce Services \$180,100 General Fund and \$603,000 federal funds in one-time programming and staffing costs in FY 2017 and \$691,100 General Fund and \$2,073,200 federal funds in FY 2018 in for 37 staff to determine Medicaid eligibility for these 35,800 individuals.

#### **Description:**

This bill directs the Division of Health Care Financing to seek a waiver for Medicaid coverage for limited family planning services and reproductive health.

#### **Impact on Children:**

This bill would effect the children of Utah by providing sexual health treatment and prevention for cervical cancer, STDs, breast health checkups and provide screening and testing for these. Sexual health education, preventative care, and family planning which doesn't not include abortion for children who are on Medicaid or are considered low income.

PTA Resolution: HEA 2010-1 and HEA 2010-2

**Notes:** Resolved, That Utah PTA work with other agencies to identify the reasons for differing pregnancy and STD rates, and explore solutions and programs adapted to cultures and ethnic groups to help reduce sexual involvement among youth. # HB0073 | CHILD PLACEMENT AMENDMENTS

**Sponsor: Peterson, Jeremy A.** 

**Status:** Enacting Clause Stricken

**Fiscal Note:** Enactment of this legislation could cost \$71,200 ongoing beginning in FY 2018. Of that amount, \$6,400 in General Fund and \$800 in federal funds is for personnel at the Department of Human Services - Division of Child and Family Services to determine whether a parent or quardian has an

outstanding felony arrest warrant. The remaining \$64,000 in General Fund is for personnel at the Office of the Attorney General - Child Protection Division to prepare and file reports with the court.

### **Description:**

This bill enacts provisions in the Juvenile Court Act related to child placement during an abuse, neglect, or dependency proceeding.

### **Impact on Children:**

Requires the Division of Child and Family Services to determine whether a parent or guardian has an outstanding felony arrest warrant before recommending the return of a child to the custody of the parent or guardian and and allows the juvenile court to deny the return of a child to the custody of a parent or guardian if the parent or guardian has an outstanding felony arrest warrant.


# HB0092 | PHYSICAL RESTRAINT IN SCHOOLS

This bill supplies better definitions and provisions on how and when to use physical restraint or escort thereby increasing the safety of every individual in the school.

# HB0110S01 | CONTROLLED SUBSTANCE AMENDMENTS

Sponsor: Ray, Paul

**Fiscal Note:** Assuming offenders under the provisions in the bill would otherwise be convicted under separate similar offenses, enactment of this bill likely will not materially impact state expenditures. However if there is a net increase in prison commitments as a result of the bill, it could cost the

Department of Corrections about \$33,000/year/prisoner for each additional commitment and \$7,500/year/offender for community probation supervision from the General Fund beginning in FY 2018. Similarly if there is a net increase in offenders mentioned above, this could cost the Board of Pardons and Parole about \$400/offender per decision from the General Fund.

#### **Description:**

This bill adds the substance 3,4-dichloro-N-[2-(dimethylamino)cyclohexyl]-N-methylbenzamide that is also known as U-47700 or "pink" to the list of controlled substances under Schedule I.

#### Impact on Children:

This bill is a Utah PTA Priority Bill because the drug "pink" is relatively new to Utah and with the quick death of two students in Park City it needs to be added to the list of controlled substances under Schedule I.

0.1 FTE staff support.

#### **Description:**

This bill: • allows a person to possess cannabis, a cannabinoid product, and an expanded cannabinoid product and to distribute the cannabis, a cannabinoid product, or an expanded cannabinoid product to a patient pursuant to an institutional review board-approved study, • allows a person conducting an institutional review board-approved study to import and distribute cannabis, a cannabinoid product, and an expanded cannabinoid product under certain circumstances, and and • creates the Cannabinoid Product Board within the Department of Health.

### **Impact on Children:**

A study is needed to understand the effects if any with regards to the the efficacy of the non habit forming parts of marijuana. This bill will allow the University of Utah to perform that study and in a year make the recommendation.

# HB0132S01 | SCHOOL BUS SAFETY REQUIREMENTS

### **Description:**

This bill: requires all new school buses purchased after June 30, 2017, to be equipped with seat belts for all passengers, exempts certain parties from liability in a personal injury action related to the use, non use, or misuse of a seat belt on a school bus, provides rule-making authority, and and makes technical changes.

### **Impact on Children:**

The National Highway Traffic Safety Administration argues that the addition of three-point seat belts could help make school buses even safer, reducing the average number of lives lost annually in school bus crashes from four to two.

PTA Resolution: SAF 2012-3 Child Passenger Safety

Notes: That Utah PTA and its constituent bodies encourage and support passage of legislation that will endorse child safety seats laws and standard seat belt laws that will increase effective use of car seats and seat belts in the state of Utah.

National PTA Public Policy: Support programs that provide for a child's health and wellness including mental health—as they progress through each stage of development into adulthood and help families monitor their child's well-being

The safety every child is a top priority of Utah PTA however with transportation budgets already underfunded and the fact that school buses are the safest form of transportation Utah PTA recognizes that mandating the purchase of the more expensive school buses with seatbelts maybe cost prohibitive for many school districts, causing them to cut funding in other areas which may be more harmful to the children of Utah. We urge that the legislature encourage districts to purchase new school buses with seat-belts when able allowing the districts to choose how to spend their budgets in the areas where they need it most.

This bill requires the State Board of Education to ask the Legislature to mitigate any financial losses, using education surplus funds, that could occur if the Board does not implement a federal program that does not directly and simultaneously advance a state goal, objective, program need, or accountability system.

#### **Impact on Children:**

The State Board already has the option to do this, but unfortunately there are not many surplus funds available to mitigate these losses. This could give Board support to not take on a federal program simply for the funds, but it could also cause issues if they choose not to implement a program, bu the legislature doesn't have the funds to cover the program. It is also difficult to determine what the actual loss of funds could be.

# **HB0137** | PUBLIC EDUCATION CURRICULUM REQUIREMENTS

This bill adds charter schools to the requirements for curriculum approval. It also adds "child sexual abuse prevention instruction" to the Human Sexuality Instruction and allows for local boards to determine whether or not that subject will require piro written consent from a parent.

### **Impact on Children:**

This bill will protect children by allowing them proper information regarding child sexual abuse prevention. Local governing boards, charter boards, or an individual school may elect to require prior written consent from a parent.

# HB0149S02 | CHILD ABUSE OFFENDER REGISTRY

Sponsor: Owens, Derrin R.

**Fiscal Note:** Enactment of this legislation could generate up to \$40,000 in annual revenue to the General Fund from the Child Abuse Offender registration fee. Registered offenders would be required to pay an annual fee of \$100.00 to the Department of Corrections to maintain the Child Abuse Offender Registry.

#### **Description:**

This bill changes the name of the "Sex and Kidnap Offender Registry" to the "Sex, Kidnap and Child Abuse Offender Registry", adds felony offenses of child abuse and human trafficking of a child to the Sex, Kidnap, and Child Abuse Offender Registry, and and makes technical and conforming changes.

#### **Impact on Children:**

Numbers show Utah is eighth highest among all states in child abuse. The state had 6,900 cases in 2014. Utah has tougher laws than other states and may pursue child abuse more vigorously and that might help explain the high rate. Utah needs to continue to take steps forward to protecting it's children.

PTA Resolution: FAM 2009-2 Child Abuse and Neglect

**Notes:** That Utah PTA and its constituent bodies advocate for adequate laws to protect children in all areas of child abuse, neglect, maltreatment, and exploitation.

# HB0155S01 | DRIVING UNDER THE INFLUENCE AND PUBLIC SAFETY REVISIONS

**Sponsor: Thurston, Norman K** 

Status: Governor Signed



**Fiscal Note:** Enactment of this bill could have a total cost of \$1,068,800 in FY 2018, \$1,171,300 in FY 2019 and \$1,273,800 each year thereafter from the

General Fund. The General Fund cost breakdown is as follows: (1) Corrections - \$630,500 in FY 2018, \$733,000 in FY 2019 and \$835,500 in FY 2020 for incarceration and supervision costs, (2) Courts - \$248,600 for additional processing and appeals costs, (3) Attorney General - \$178,200 for appeals costs, and and (4) Board of Pardons and Parole - \$11,500 for additional hearings. In addition, this could cost the Department of Public Safety \$19,400 one-time from the Transportation Fund - Public Safety Restricted Account in FY 2017 for programming changes. This estimate assumes a ten percent increase in relevant cases which equates to 285 in state courts (plus 855 local justice court cases). Of these cases, an estimated 16 individuals may be committed to prison and an additional 41 sentenced to probation,

#### Description:

This bill reduces the blood alcohol content limit for driving under the influence, reduces the blood alcohol content limit in relation to certain criminal offenses, defines "novice learner driver", defines "novice licensed driver", and modifies the definition of "alcohol restricted driver" to include a novice learner driver and a novice licensed drive.

### **Impact on Children:**

This bill will lower the allowable blood alcohol level while driving making Utah streets safer for all of Utah's children and their families

PTA Resolution: <u>HEA 1981-1 Driving Under the Influence</u>

**Notes:** That PTA continue to work to encourage more stringent laws and penalties concerning driving under the influence of alcohol.

Utah PTA supports high standards for teacher preparation, licensing, and hiring. All teachers should be prepared with proper pedagogical skills before entering the classroom. We oppose the portion of the bill that allows a teacher who receives a license through an alternate route two years to complete the assessment. Utah PTA feels this bill oversteps the bounds of the legislature as "general control and supervision of the public education system shall be vested in [the] State Board of Education."

# HB0166S01 | SCHOOL AND INSTITUTIONAL TRUST FUND AMENDMENTS

Sponsor: Moss, Jefferson

**Fiscal Note:** Enactment of this legislation may save about \$200 ongoing in meeting costs from the School and Institutional Trust Fund Management

Account as a result of reducing the required minimum number of board meetings from nine to six.

#### **Description:**

This bill makes minor changes to the code for the operation of the School and Institutional Trust Fund Office (SITFO). It includes a change to the required number of board meetings and a change to the membership of the nominating committee.

### **Impact on Children:**

This bill will allow for the more efficient operation of the School and Institutional Trust Fund Office (SITFO) which is the office responsible for investing the permanent state school fund.

PTA Resolution: EDU 2015-1 School Trust Lands

**Notes:** Resolved That Utah PTA encourage State and local officials to take all necessary steps to assure that management of the School Trust Lands is in accordance with trust duties and principles including undivided loyalty to the beneficiaries, a duty to make trust property productive, a duty to keep and render accounts, and a duty to exercise prudence and skill in administering the trust, thereby obtaining much-needed revenue for Utah's public schools.

### HB0168S02 | KINDERGARTEN SUPPLEMENTAL ENRICHMENT PROGRAM

Sponsor: Snow, V. Lowry

Status: Governor Signed



**Fiscal Note:** Enactment of this legislation appropriates \$186,600 one-time in FY 2018 and \$20,000 ongoing beginning in FY 2018 from the Education Fund

to the State Board of Education to administer a kindergarten supplemental enrichment grant program. In addition, the bill appropriates \$2,880,000 as a transfer of federal Temporary Assistance for Needy Families (TANF) funding from the Department of Workforce Services (DWS) to the State Board of Education for grants to schools for kindergarten supplemental enrichment programs. Intent language in the bill directs DWS to allocate \$2,880,000 each year, for the next three fiscal years, from federal



#### **Description:**

This bill establishes the kindergarten supplemental enrichment program specifically for eligible schools in which at least 10% of the students experience intergenerational poverty or 50% of the students are eligible to receive free or reduced lunch in the previous year.

#### **Impact on Children:**

Children from lower income families are at risk of entering kindergarten behind their peers, which is a predictor of subsequent academic performance. This Bill will create kindergarten enrichment programs to help children in poverty situations. The fiscal note requires this program to be paid using Temporary Assistance for Needy Families reserve funding. (TANF Funds).

PTA Resolution: FAM 2009-1 Early Childhood

**Notes:** Resolved, That Utah PTA and its constituent bodies educate parents on the importance of quality early childhood learning experiences, and be it further Resolved, That Utah PTA and its constituent bodies work collaboratively with existing early childhood programs to better coordinate services, and and be it further Resolved, That Utah PTA and its constituent bodies advocate for policies and funding to improve early childhood services throughout the state.

**National PTA Public Policy:** Early Learning and Childhood Education 1. Ensure family engagement initiatives begin at birth, at home and in other early learning environments to guarantee coordinated family engagement throughout childhood. 2. Increase access to high-quality, public pre-kindergarten for all students to prepare them for successful kindergarten entry 3. 

Also, problematic is the fact that those who created this bill did NOT seek advice with anyone in the prevention community about this bill. I was at a Prevention Dimensions (which is under the direction of Parents Empowered and the USBE) board meeting last week when this bill came up and was told that someone from the board had called the legislators who are sponsoring the bill and was told they just wrote it without consultation. Discouraging to us are lines 1571-1625 which states that the State Board of Education is to create a prevention program for 8th and 10th grades. Our concern there is that if they wait until 8th and 10th grade it is too late. Not only that but the State Board already has a program concerning prevention that starts in 4th grade.

DJJS costs could decrease by \$11,478,000 from the General Fund beginning in FY 2018 for elimination of work camps and residential observation and assessment, as well as reduced detention and secure care. DJJS federal fund expenditures could decrease by \$625,100 and transfers could decrease by \$80,000 beginning in FY 2018 associated with the above changes. The net General Fund impact on DJJS is cost increase of \$362,400 ongoing beginning in FY 2018. Assuming development begins in FY 2018, delayed implementation of programs and tools until FY 2019 results in no change to the fiscal impact. DJJS has indicated that it can absorb the additional costs. (3) Costs for the Office of the Attorney General could increase by \$178,200 ongoing from the General Fund for additional legal services. (4) Costs for the Commission on Criminal and Juvenile Justice (CCJJ) could increase by \$221,500 ongoing and \$25,900 one-time from the General Fund beginning in FY 2018 to oversee the Juvenile Justice Reform Program, coordinate performance, and evaluate implementation. (5) Costs for the Judiciary could increase \$912,800 ongoing and \$700,000 one-time from the General Fund for new court services, staff, case management software enhancements, and probation workload changes. These amounts assume \$3,636,000 in expanded programs for youth on probation will be covered within the budget of the Department of Human Services at no cost to the Judiciary.

### **Description:**

This bill: keeps low-risk youth offenders in their homes, when possible, using a variety of alternative programs and limit the amount of time youth can spend in detention centers, put a cap on fees and service hours that a juvenile judge can order, and require that lawyers be provided to all juveniles charged criminally.

WPU Value appropriated by the Legislature to adjust the number of local property tax increments quaranteed through the Voted & Board Local Levy Programs as outlined in the bill. The number of tax increments guaranteed by the state will increase over time from the 20 currently guaranteed to a maximum of 38 increments. Depending on the cost of increasing the number of increments and the amount of funding allocated by the Legislature, the state guarantee rate applied to all increments guaranteed may also increase as provided in the bill. Bill provisions require the Legislature to annually appropriate an amount equal to 1/3 of the funds allocated to increase the WPU Value to increase the number of tax increments quaranteed. Based on current estimates, 1/3 of the funds to increase the WPU Value by 1 percent equals \$10.0 million. Assuming a 3 percent increase in the WPU Value appropriated in FY 2018, approximately \$30 million would be needed to implement the provisions as outlined in the bill. Estimates indicate it costs approximately \$17 million to increase the number of Board Local Levy increments quaranteed from 4 to 6 (Priority 1), \$61,000 to increase the number of Voted Local Levy increments from 16 to 18 (Priority 2), and the remaining funding would be available to increase the state quarantee rate (Priority 3). The actual amount available to implement the provisions outlined in the bill is not currently available. The actual number of new increments guaranteed and the final state guarantee rate for FY 2018 will not be available until the Legislature determines the amount of new funding to appropriate for a WPU Value increase

#### **Description:**

This bill directs the Legislature to annually appropriate an amount equal to one-third of the funds allocated for an increase in the weighted pupil unit value to increase the number of guaranteed local levy increments for lowest funded LEA's.

### **Impact on Children:**

Studies showing best practices indicate that parents and community who work together to promote good attendance and to address the challenges that keep children from getting to and staying in school and provide early identification programs have a positive effect on school attendance. Removing all compulsory education penalties may be detrimental to children who are in high-risk households where education may not be a priority. Studies from the Utah Education Policy Center at the University of Utah and elsewhere indicate that chronic absenteeism is a proven predictor of lower academic performance and higher dropout rates. The ultimate goal of truancy prevention programs and compulsory education penalties is to help reduce the number of dropouts in the state's education system.
